

Vendor 1099-NEC

The MCSJ system can print laser 1099-NEC forms and generate a 1099-NEC file that can be transmitted electronically. In order to print or generate 1099-NEC's:

- Vendors need to have the 'Non-Employee' 1099 type assigned in Vendor Maintenance.
- Vendors need to have a Tax Id assigned in Vendor Maintenance.
- Vendor name (legal name) and address information should be entered properly in Vendor Maintenance.
- The YTD paid totals for the vendor must exceed \$600 or another specified dollar amount.



Note - Please review the IRS "Instructions for Forms 1099-MISC and 1099-NEC" before proceeding.

We recommend the following process when printing or generating 1099-NEC's:

- Review the 1099-NEC Report Listing and make any necessary corrections to vendors. This listing will show each vendor who will get a 1099-NEC. It will list their Tax Id, 1099 Type, and total dollar amount.
- Regardless of whether you will be filing electronically or printing forms, generate the 1099-NEC magnetic media file. An error list will print that will show what corrections should be made before you print 1099-NEC's.
- Once the necessary corrections have been made, you may generate the 1099-NEC file and print the 1099-NEC forms.



Note - If certain amounts paid to a 1099-NEC type vendor need to be excluded from the 1099-NEC, the 1099 Exclusion button may be selected on any paid purchase order line items for that vendor.

1099-NEC Report Listing

This option will list the vendors scheduled to receive a 1099-NEC. The Tax Id, 1099 Type, and dollar amount for each qualifying vendor is provided.

Finance > A/P > Vendor > Vendor 1099-NEC Forms/Listings/Labels.

Using the **Print Type** combo box, select *Report Listing*.

Vendor 1099-NEC Magnetic Media

This menu option will create an electronic file(s) containing 1099-NEC information. It will also generate an error report containing information that should be corrected before printing 1099-NEC's or submitting the 1099-NEC file.



Note - 1099-NEC electronic filings are NOT part of the Federal Combined Filing Program. If your state requires an electronic 1099-NEC file, a 2nd state-specific file will be created. For further information on electronic filing, refer to IRS Publication 1220 (PDF), Specifications for Filing Forms 1097, 1098, 1099, 3921, 3922, 5498, and W-2G Electronically. Refer to your state's website for additional information on any 1099-NEC electronic filing requirements.



Note - If you are only generating the 1099-NEC Magnetic Media file to view errors, you may type fake information in any required fields. This will enable you to avoid receiving error messages that appear for not completing required fields.

Payment Year - Specify the year for which the 1099-NEC's are being generated.

Payer Id - Enter your organization's Tax Id.

Minimum 1099 Reportable Amount - The dollar amount may be changed. All 1099-NEC type vendors with YTD totals greater or equal to this amount will appear on the file.

Your organization's name and address information should default from the system parameters. If this information is incorrect, change it.

The Contact information fields must be completed. This refers to your organization's contact person for 1099 information.

File Type - Using the combo box, select from Original or Test.

Transmitter Control Code - A 5 digit number must be specified in order to generate the file. The IRS provides this number.



Note - Edmunds GovTech cannot provide your Transmitter Control Code. Form 4419, Application for Filing Information Returns Electronically, must be filed with the IRS in order to receive this number.

Click **Next** to generate the file and produce the error report.

The system will generate a file named IRSTAX to the MCSJ/importFiles directory. If applicable to your state, a separate state file will also be generated to the same directory.

Print Type - Leave the default, *Laser Printer Forms*.

Minimum 1099 Reportable Amount - The dollar amount may be changed. All 1099-NEC type vendors with YTD totals greater or equal to this amount will appear on the file.

Payment Year - Specify the year for which the 1099-NEC's are being generated.

Payer Id - Enter your organization's Tax Id.

Your organization's name and address information should default from the system parameters. If this information is incorrect, change it.

An alignment form may be printed by clicking the **Print Alignment** button. The alignment may be adjusted using the X and Y Offset fields. X adjusts right and left. Y adjusts up and down.

Click **Print**.



Note - A 1096 Summary form can be printed by organizations who need one to file paper forms. Select '1096 Form' from the Print Type combo box and load your 1096 form into the printer. Contact information fields will enable and must be completed before clicking Print.

Recalculate Vendor Paid YTD (Fiscal Year Entities Only)

The YTD paid totals displayed on the Vendor Maintenance screen can be recalculated for a particular calendar year. This routine can be run in January by non-calendar year organizations.



Note - This routine has NO effect on 1099 totals.

Finance > A/P > Vendor > Recalculate Vendor Paid YTD.

Recalculate YTD to Calendar Year - Enter the calendar year to recalculate.

Click **Next** to run the routine.
