

# Logics 2023 Q1 Release Notes

The items below are released as fixes or features as part of the products listed below. The release will be effective close of business April 3, 2023.

Logics has upgraded the reporting engine to the next version 12.8 SP4 so that we can provide better support for Chrome based browsers. The main benefits of the upgrade will be improved graphics for dashboards and graphs. Existing standard reports will have as few changes as possible to prevent comparison issues.

365	Add date checks to Collections	Create Batch - If batch date entered is in past or is not within the current year, give warning message allowing to continue.  Reconcile Batch Verify payment date is within the current fiscal year (from Financial Management) - if not, give warning allowing to continue. If no Financial Management, do not check.  Update Batch - reverify within current or prior fiscal year. If not, give warning that batch date will not match fiscal year allowing to continue.
382	Add additional dialog to endorsement printing	Added an additional dialog to alert cashiers when the printer did not correctly load a check for endorsement printing. This was causing the endorsement text to print halfway down the check instead of at the top. When the dialog appears on screen, the check will be ejected from the printer, and the cashier will be asked to re-insert the check to print the endorsement.
481	Add new setting to auto print receipt after endorsement	If the setting CC_AutoReceiptPrintAfterEndorsement is set to 1 and the receipt balance is 0, a checked checkbox will be added to the endorsement dialog. The checked checkbox will cause the receipt to print immediately following the endorsement print. If the cashier unchecks the checkbox before the endorsement prints the receipt will not print.

1686	Asset Cost Report	Added an asset cost report for customers that have the cost of their assets stored in the system. The report will display the fiscal year the asset was purchased, the purchase cost of the asset and using a depreciation calculation the current value of the asset.
1697	Refund batch update showing incorrect Invoice batch #	A change was made in the code to show the Batch Number rather than the Batch Id in the message.
1700	Budget Adjustment on a non-budget bill	Changed budget billing balance calculation to include non-budget bill records with budget adjustments on the basis that the budget adjustment makes the bill implicitly a budget bill.
1703	Export Longitude before Latitude for Neptune360 only	Reversed Latitude and Longitude order in Neptune 360 layout only. This now matches the current specification. The previous order was based on an old error in the specifications for the earlier versions of the software; because of that error there are settings in the earlier versions to account for the reversed ordering. Since customers using the older versions that have the setting configured for the previous ordering those versions of the Neptune interface keep the previous ordering. Neptune 360 is the first version without the ability to reverse to accommodate that old error.

1738	Remove CondorServices Dependencies in Utility Management	The customer tab (Account Maintenance - View Mode), Contact maintenance (Account Maintenance - Edit Mode) and Service Applications have dependencies on Condor Services. If Condor Services isn't started early in the day and the RAM usage is high on the server, it occasionally fails to start and errors on these items (most often on Service Application entry). Removing these dependencies removes this issue for customers not using Revenue Management.
1739	Revise Mailing Label Report to Include Range for Account Numbers	Made a change to the existing Mailing Label report to allow the customer to select a range of account numbers to be printed.
1756	Voided Adjustment Batch transactions showing in Adjustment by Service Code report	A correction has been made in the query for the Adjustments By Service Code report to prevent voided batches appearing in the report.
1767	Report of service address with no active tenant - Add 'By Service Address' option to Vacant Accounts Listing	Added the option By Service Address to the Vacant Accounts Listing report.
1800	Deposit pages in Account maintenance freezing and timing out	Modified indexes and reworked the logic in the view UBvwDeposit to improve the performance of the query that was timing out.
1812	Comparison Usage methods based on billed usage (e.g., Same Month Last Year) break across a billed usage scale change (e.g. change from billing in thousands to billing in single units)	Add a comparison usage multiplier to scale the historical usage to match the new usage

143	Conditional text in bill ready and bill reminder emails for customers enrolled in auto pay or bank draft	Added ability to add customizable blocks of text to the bill ready and bill reminder emails. There can be a block of text for customers enrolled in auto pay, and another block of text for customers enrolled in bank draft. The blocks of text are designated by placing the appropriate tag at the beginning and end of the text to include for the group of customers. The tags are listed on the email configuration page. For example the text placed between the tags {LinkedBill_AutoPayActive_StartCond}{LinkedBill_AutoPayActiveEndCond} will only be displayed for emails sent for bills enrolled in automatic payments.
249	Incomplete Tenders page	Added a page for administrators to view and edit customer tenders when the Blue Pay response does not reach Online Bill Pay. Notification of these rare incomplete tenders will be included in the daily scheduled task summary.
256	Add search feature for Admins	Added new page to search for utility accounts, invoices and service applications that customers have linked using Online Bill Pay. Double clicking on a linked bill in the search results will take you to a page which list all customer profiles that have linked the bill, the last 20 payments to this bill using Online Bill Pay, and the last 20 emails sent to customers that have linked the bill.
256	Scheduled Payments page	Added new page to view the payments scheduled by customers.

This will prevent customers from directly linking the invoice and from the invoice being suggested for linking based on the customer number.
