

Logics 2023 Q4 Release Notes

The items below are released as fixes or features as part of the products listed below. The release will be effective close of business January 2, 2024. These release notes will focus on the new Asset Location or Service Line Materials reporting feature described below.

Asset Locations and Service Line Materials Tracking

Logics has added a new Asset Location record to the system to represent a "location" for one or more assets associated with an Account Location (i.e., all accounts with a common base Account Number). This provides continuity across turn-on/turn-off (of accounts) and change-out/add/remove (of assets) and a way to group related assets (e.g., backflow devices associated with specific meters).

The following instructions describe how to use the new Asset Location feature in the Utilities management module.

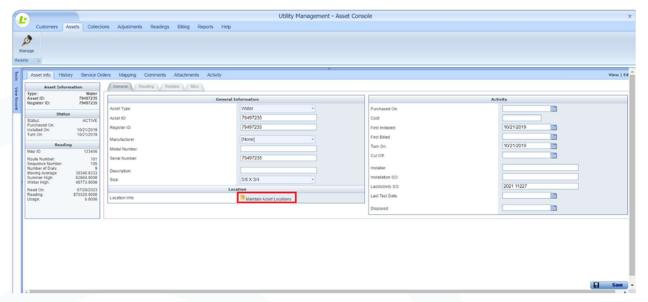
Maintain Asset Location

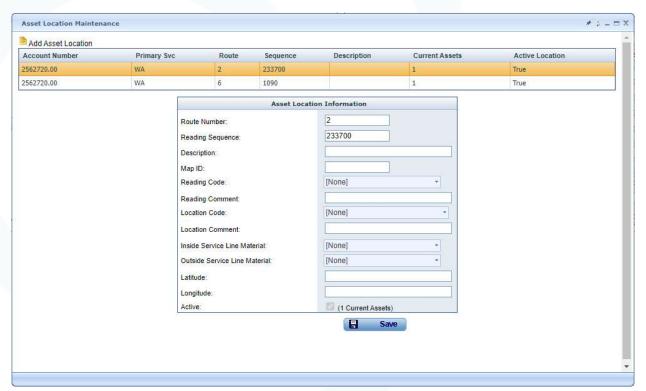
Several fields previously on the asset which are truly characteristics of "the asset at the location" have been moved from the asset to the asset location:

- Route Number
- Reading Sequence
- Map ID
- Latitude*
- Longitude*
- Reading Instruction Code/Comment & Text
- Meter Location Code/Comment & Text

The Asset Location information can be accessed by clicking on the Maintain Asset Locations link.







Note: Latitude and Longitude associated with MXU are currently still on the asset with the related MXU Number and MXU Type for compatibility.

These fields are no longer available directly in the asset maintenance in their previous locations and may be maintained on the asset location record (or records) associated with the asset. Note that, if multiple assets are associated with a single asset location, changing the asset location data impacts all of them.



Additionally, a "Description" field exists on the new record to allow distinguishing data. For example, if a particular asset location is for a barn meter, then the description might be something like "Barn". The Description field on the asset may previously have been used for a similar purpose and the Description on the Asset Location will have been prepopulated with data from that field on the Asset though it is not a direct migration; the old field on the asset still exists independently of it.

Service Materials Tracking

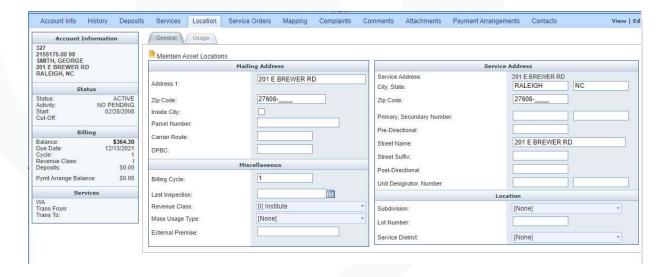
There are also two new fields added to the asset location record:

- Service Line Material (Inside)
- Service Line Material (Outside)

These allow selecting the options specified by the EPA and/or local service line materials reporting. Inside refers to the customer owned section of the line and Outside to the utility owned section of the line.

Maintain from Account Location Maintenance

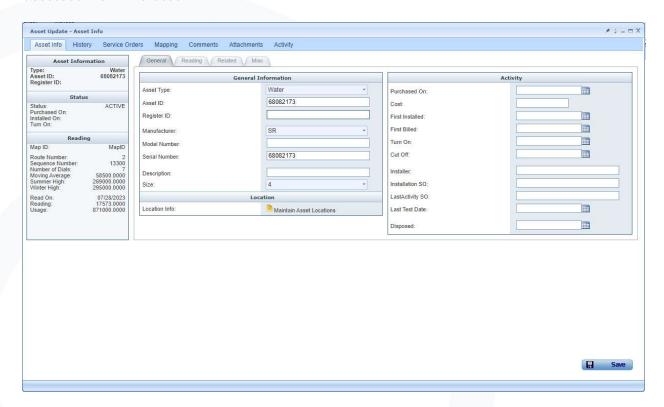
Asset Locations may be added and maintained in a maintenance accessible from the Location tab on the account. Like the rest of the data on the location tab, this is shared across all accounts at the location.





Maintain from Asset Maintenance

Asset Locations may be maintained (though not added) in a maintenance accessible from Asset Maintenance; all asset locations with which the asset has been associated may be accessed from the asset.

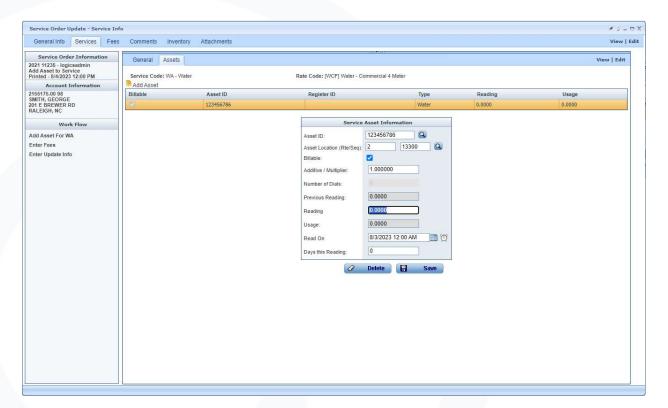




Maintain from Service Orders

Asset Locations may also be maintained and added from Service Order data entry on the following Service Order Types:

- Turn On Existing
- Add New Service
- Add Asset to Service

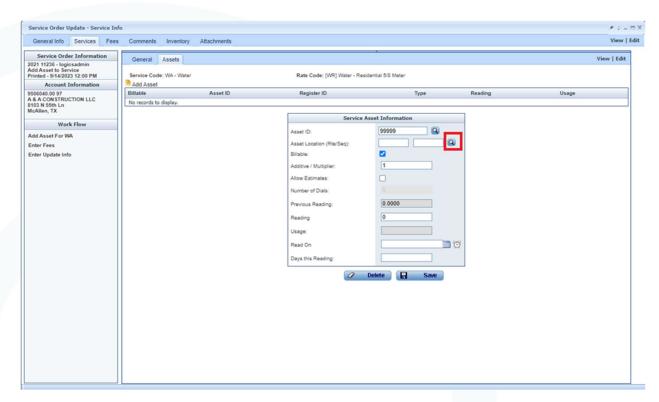


On these Service Order types it will be possible (and, in some cases, necessary) to select or create the asset location you want to associate the asset being added with.

On a **Turn On Existing** Service Order where the asset is inherited from the previous account (the most common case) it will populate the existing asset location though it will allow the user to change the asset location if desired.

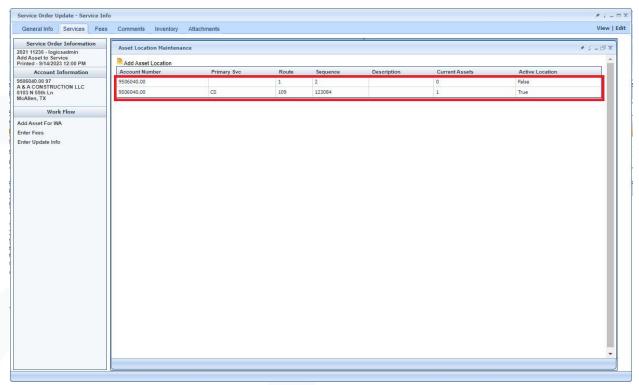


For an **Add New Service** or **Add Asset** Service Order or for a **Turn On Existing** where no asset has been inherited and one needs to be added it will be necessary to select the asset location.



You can select or add an asset location either by clicking on the lookup next to the Asset Location Route/Seq entry or, if there is a single asset location for a given route/seq combination associated with the location it will be possible to enter the route and sequence directly into the fields and it will select the appropriate asset location. If no such asset location exists or if there exist multiple asset locations on the account with that route/seq combination, then it will open the selection/maintenance dialog for the user to select or create the appropriate asset location.
