Changes made with the void/escheat/reinstate page and with the journal import page to prevent double clicking on the button or clicking a second time while it is processing which will prevent duplicate journals being created. The change was made in the budget export to improve the runtime for the query and a CommandTimeout line added to extend the length of time for the query to run to prevent 'The wait operation timed out' error.
1329	PO Listing - Open As of.	Changes have been made for the PO Listing to allow presentation of POs that were opened within the date range.
1335	Add options to custom report for Purchase Orders.	Added Purchase Order data to the custom report page.
1344	Purchase Card Invoice amount won't save.	Correction made to display the 'Invoice has been previously entered for vendor would you like to continue?' message after loading a recurring payable into a purchase card batch and the Allow Duplicate Invoices with Warning flag is set on the security group.

1821	Additional Fields for Asset Location.	<p>Added an "Asset Location" table to handle information now stored on the asset which is location related and should be location persistent such as:</p> <ul style="list-style-type: none"> Route/Sequence Map ID Reading Instruction Code/Comment Meter Location Code/Comment <p>This location will be available to select or create as part of appropriate SO types (Add New Service, Turn On Existing, Add Asset) and may also be maintained/changed from asset maintenance.</p> <p>This will mean that theoretically an asset could be linked to two asset locations (e.g. a meter for an upstairs apartment on the apartment account as a normal meter and on the main house account as a deduct) but it will, importantly, leave the location specific information in a place that cannot migrate to a new location. Also, it provides a mechanism for a "vacant asset location" which once had but no longer has an asset in place.</p>
